These Terms & Conditions ("Terms") govern your access to and use of the Virema mobile application, website, and related services operated by Beijing Zhongmaque Culture Media Co., Ltd. ("Virema," "we," "us," or "our").

By creating an account or using Virema, you agree to these Terms. If you do not agree, you should not use the platform.

1. About Virema

Virema is a relationship and personal growth platform designed to help users build meaningful connections, communicate, participate in educational experiences, and use trust-oriented platform features.

Virema is not limited to dating. The platform may expand to include communities, educational content, forums, streaming, professional services, subscriptions, and other social or personal growth features.

2. Eligibility

You must be at least 18 years old to use Virema.

By using Virema, you confirm that:

- you meet the minimum age requirement;
- you have the legal capacity to agree to these Terms;
- you will use the platform in accordance with applicable laws;
- you will not use Virema for illegal, fraudulent, abusive, or harmful purposes.

We may restrict, suspend, or terminate accounts that do not meet eligibility requirements.

3. Account Registration

Virema uses phone-based account registration.

Each phone number may be associated with one account.

You are responsible for keeping your account secure and for all activity that occurs through your account.

You agree not to:

- create false or misleading accounts;
- impersonate another person;
- use another person's phone number or identity;
- create accounts for fraud, spam, abuse, or evasion of enforcement actions.

4. Profile Information

You may provide profile information, including name, nickname, date of birth, gender, country, city, photos, and other information made available by the platform.

You are responsible for ensuring that the information you provide is accurate and does not violate these Terms.

Nicknames may be used in general platform features.

Certain features, including Make Right Choice (MRC), may display additional profile information where applicable.

5. Account Changes and Deletion

You may update certain account and profile information.

You may request account deletion at any time through the platform or support channels.

After deletion:

- your public profile may be removed;
- your profile photos may be removed;
- messages previously sent to other users may remain visible to recipients;
- reports, feedback records, moderation records, security records, audit records, and legal records may be retained for legitimate purposes.

6. User Content

User Content includes any content you upload, submit, send, display, or make available through Virema, including photos, messages, audio, video, feedback, reports, and profile information.

You retain ownership of your User Content.

By using Virema, you grant Virema a limited, worldwide, non-exclusive, royalty-free license to host, store, process, display, transmit, moderate, and use your User Content as necessary to operate, improve, secure, and provide the platform.

You are responsible for your User Content.

You must not upload or share content that is illegal, abusive, deceptive, exploitative, sexually explicit, fraudulent, hateful, threatening, or otherwise violates these Terms or our Community Guidelines.

7. Screenshots and Copies by Other Users

Virema cannot guarantee that other users will not screenshot, record, photograph, copy, save, or redistribute content you share.

You should use caution when sharing personal information, photos, messages, or media with other users.

8. Photos and Media Rules

Users may upload profile photos and share media through platform features where available.

Profile photos may be subject to moderation.

Prohibited media may include:

- explicit nudity;
- pornographic content;
- sexually exploitative content;
- non-consensual intimate content;
- images of minors used in a misleading or inappropriate way;

- violent or threatening content;
- impersonation or fake identity content;
- fraudulent or scam-related content.

Beachwear, sportswear, and ordinary social photos may be allowed when they are not sexually explicit, exploitative, or misleading.

Virema may remove content, warn users, restrict accounts, suspend accounts, or permanently block accounts when rules are violated.

9. Messaging

Virema may provide private communication features, including text, images, audio, and video.

Video messages may be subject to duration limits.

Messages cannot currently be recalled, unsent, or edited after delivery.

Users are responsible for what they send.

Virema may review messages or related information when necessary to investigate reports, enforce rules, respond to safety concerns, or comply with legal obligations.

10. Trust Indicator System

Virema may use a Trust Indicator system.

Trust may be influenced by factors such as:

- phone verification;
- identity verification;
- profile completion;
- serious participation;
- QR meeting confirmation;
- moderation history;
- community trust signals;
- other platform activity.

Trust indicators are informational only.

They do not guarantee safety, honesty, compatibility, relationship success, or future user behavior.

Virema may change how Trust Indicators are calculated or displayed.

11. Verification

Virema may offer verification features, including phone verification, photo verification, and identity verification.

Identity verification may require documents such as:

- passport;
- driver's license;

- government-issued ID;
- other approved documents.

Verification may be reviewed by Virema staff and may later include automated or AI-assisted review.

Verification does not guarantee that a user is safe, trustworthy, compatible, or suitable for any relationship.

If a verification document is rejected, the user may be allowed to submit another document.

If a document appears fraudulent, Virema may reject verification, restrict the account, suspend the account, or take other appropriate action.

12. Make Right Choice (MRC)

Make Right Choice (MRC) is an optional Virema feature designed to encourage intentional, meaningful, and responsible relationship building.

Participation in MRC is voluntary.

Users may leave MRC at any time.

Users who leave MRC may become unavailable in MRC discovery or search features while existing chats or account access may remain available.

Users may participate in multiple connections or interactions available through the platform.

- personal transformation.

MRC is educational and philosophical in nature.

MRC is not medical, psychological, psychiatric, legal, financial, or professional advice.

13. Educational Content

14. Offline Meetings

QR meeting features, verification, Trust Indicators, reports, and safety tools may support safer interactions, but they do not eliminate risk or guarantee safety.

If users meet without using available safety-related features, they remain responsible for their own decisions and actions.

15. Location and QR Meeting Features

Certain features may request location access, including meeting-related features, QR meeting confirmation, safety features, regional services, or other optional platform functions.

By using such features, you agree that Virema may process related event information for safety, audit, moderation, legal, fraud prevention, and platform integrity purposes.

Virema does not use location information to guarantee user safety.

16. Reports, Blocking, and Moderation

Reports may be reviewed by authorized Virema staff.

Virema may take actions including:
